1. You will need to **register with Packers & Stockyards Administration** 210 Walnut Street Suite 317, Des Moines, IA 50309. Telephone No. (515)-323-2579.
2. **Complete and return the application.**
3. **Submit** your check or money order in the amount of **Fifty dollars** (\$50.00), made out to the South Dakota Animal Industry Board, 411 South Fort St., Pierre, South Dakota 57501-4503.
4. **Submit a current copy of your financial statement.**
5. **Submit** a copy of your **bond or letter of credit** to this office.
6. If you have any **agent-buyers** operating under your license and bond **submit** their **names** on the last page of the application.

Upon receipt of these items you will be issued a South Dakota Livestock Dealers License
